Rabbit Control Operation Planned for Lake Hayes Walkway Area

Queenstown Lakes District Council (QLDC) has employed the services of a professional contractor to carry out rabbit control in the Lake Hayes Walkway area between Marshall Road and Rutherford Road. This operation aims to reduce rabbit numbers to decrease the effect that they have on the vegetation in the Lake Hayes area.

The rabbit shooting operation will take place over four nights on **Tuesday 7 May 2024**, **Tuesday 14 May**, **Tuesday 18 June** and **Tuesday 25 June 2024**. The control will be carried out from **8.00pm to 2.00am**.

This operation will be weather dependant. If the control work is cancelled due to bad weather it will be postponed to the following night of the scheduled shoot date.

Residents and businesses in the neighbourhood will be notified via a letter drop with details of the rabbit control operation.

Experienced professional contractors will carry out the night shooting operation within a cordoned off area. Signage and personnel will be at all main entry points to ensure no one can enter the area during the operation.

- Please respect the cordon and **DO NOT ENTER** when signage and personnel are present.
- Public walking tracks will be closed during this operation. If members of the public are asked to leave the area for their safety, please do so.
- · Police have been notified of this rabbit control operation.
- Department of Conservation has been informed of this activity and has approved temporary closure of this track.
- Please be aware that noise from firearms, which are supressed, may be heard around the Lake Hayes area.
