Queenstown Lakes District Council gives notice as of 20 February 2025 that the Summary of Decisions Requested for the Upper Clutha Landscape Schedules Variation to the Proposed District Plan is now available

The Upper Clutha Landscape Schedules Variation proposes to amend Strategic Policy 3.3.36 of Chapter 3 – Strategic Directions of the PDP, introduce additional landscape areas into Schedules 21.22 and 21.23, and make minor amendments to the preamble of Schedule 21.23 of Chapter 21 – Rural Zone. The Variation does not propose any changes to the existing policies or rules applying to subdivision and development within the Rural Zone. The proposed additional landscape schedules are accompanied by maps which are to be incorporated by reference into the Proposed District Plan as part of the Variation.
