Notification of a Reserved Area for a Special Event

Public Notice is hereby given that pursuant to the Queenstown Lakes District Navigation Safety Bylaw 2018, Bylaw Clauses 31 has been invoked to temporarily establish a Reserved Area within Queenstown Bay to allow for the running of a fireworks display and to ensure the safety of all Queenstown Bay users.

This Reserved Area will be in place on Saturday 13 July 2024 and applies to both private and commercial vessels and watercraft.

Date: Saturday 13 July 2024

Time: 3.00pm – 7.00pm (from 6.00pm the Fireworks Exclusion Zone will be in force)

Location: Inner section of Queenstown Bay (Fireworks Exclusion Zone, from a line between

45 02 03.6S and 168.39.22.6E and 45 02 12.7S 168 39 32.12E WGS84 Lat-Long), in line with Queenstown Bay Fuel Wharf through to the Queenstown Gardens area.

Between 3.00pm and 6.00pm, the area will be subject to a no Wake Zone, and vessels will not travel in excess of 5 Knots for the period that the exclusion zone is established.

From 6.00pm to 7.00pm on 13 July 2024, in the interests of public safety, the Queenstown Bay Exclusion Zone will be in force. No unauthorized vessels are to enter the Exclusion Zone until all clear is given.

The Barge will display a red bravo flag during day light hours and a single red all round masthead light outside of day light hours.

All vessels that remain within the exclusion zone during lockdown must be tethered to the shore no later than 6.00pm and must remain so for the duration of the display until the 'all clear' is given.

The Harbourmaster's staff may be onsite to monitor compliance with the Reserved Area. Their directions must be followed at all times.

All boaters are reminded that, while on the water, they must comply at all times with the Maritime Transport Act 1994 and the QLDC Navigation Safety Bylaw 2018. These laws incorporate rules around speed and visibility at night, including that navigational lights on your vessel comply and are operational. Waterways staff may be on hand to monitor compliance on the night and may issue infringements if boaters fail to comply with these rules.
